- **Funds Available and Anticipated Number of Awards.**

Triton will make a commitment of up to USD \$100,000 in total fellowship support for FY2009-2010, for pre- and post-doctoral research. Total pre-doctoral supplemental support will be in the range of \$1,000-\$15,000 per award and total post-doctoral support will range from \$1,000-\$25,000 per award based on experience and priority of the proposed project to Triton's development pipeline. Support under this fellowship program is contingent upon the availability of funds, the submission of a sufficient number of meritorious applications, and relevance to Triton's preclinical priorities (www.tritonbiopharma.com).

- **Budget and Project Period.**

The total project period for an application submitted to this fellowship program may not exceed 1 year.

- **Eligible Pre- and Post-doctoral Candidates.**

Students in all stages of Ph.D. research and early post-doctoral studies are eligible to apply.

I. Purpose

The purpose of Triton's Fellowship Program is to support and stimulate translational research leading to the development of novel and more effective chemotherapeutic interventions; to facilitate the production, understand the mechanism of action and to promote the development of novel therapeutics based on marine derived alkaloids, peptides and other natural products, which have promising activity in animal models, and are either part of Triton's licensed portfolio or maybe of interest in regard to licensing to Triton BioPharma. II. Application Submission Procedure

To submit an application to the Triton Fellowship Program, applicants must submit an Application Package via e-mail to **careers@tritonbiopharma.com** quoting “**RFA-Triton-09-06**” in the subject line. Applications must only be submitted electronically in Microsoft Word or PDF format. **PAPER APPLICATIONS WILL NOT BE ACCEPTED.**

The Application Package must include the following (*in Microsoft Word or PDF format*):

- 2 page NIH formatted curriculum vitae (students early in their career should include an NIH CV of their mentor)
- 2-3 page proposal describing the research project for funding

III. Application Processing

Applications **may** be submitted on or after the opening date and **must** be successfully received by Triton no later than **5:00 p.m. E.S.T.** on the application due date. If an application is not submitted by the due date and time, the application may be delayed in the review process or not reviewed.

Once an application package has been successfully submitted via **careers@tritonbiopharma.com**, an acknowledgement of receipt will be sent via e-mail. Applications will be evaluated for completeness and responsiveness by the Review Committee.

Note: *Since email transmissions may be unreliable, it is the responsibility of the applicant to confirm successful submission in the event that no acknowledgement of receipt is received within 48 hours.*

IV. Funding Restrictions

All awards are subject to careful consideration and review, and will remain contingent upon the availability of funds, the submission of a sufficient number of meritorious applications, and relevance to Triton’s preclinical priorities.

V. Review and Selection Process

Applicants may undergo 2 levels of review in the award selection, as described below:

1. *Preliminary Review:* Applications received that are complete and responsive to the Triton Fellowship Program objectives will undergo preliminary review of the scientific merit of the proposed research, as well as the relevance and potential significance to Triton’s project priorities. Award selection will involve a critical review of the applicant’s track record of research and industry experience, as supported by publications, presentations and patents.

2. *Project Presentations:* Applicants that are selected from the Preliminary Review will be required to prepare a PowerPoint presentation for submission to the Triton Fellowship Program Review Committee. The Review Committee will expect candidates to be available to present and defend their projects in front of the Committee (or by other means if attendance is impossible) during June 2009 (exact dates TBA).

VI. Award Notices

A formal notification in the form of a Notice of Award will be provided to the applicant. Once all administrative and programmatic issues have been resolved, the Notice of Award will be generated via e-mail notification to the recipient.

The specific timelines, milestones and funding levels agreed by Triton BioPharma shall be included in the terms and conditions of the award. It is recognized that milestones and timelines may require revision and renegotiation during the course of the project period.
